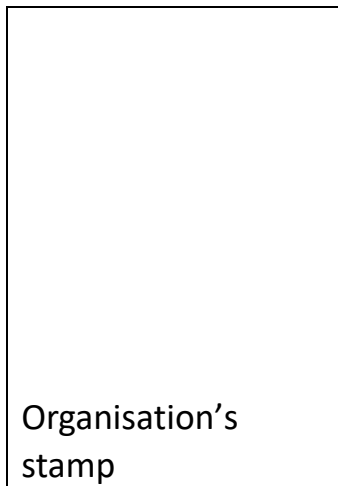

4. Effectiveness of approach/method to developing competency specification and production of Units of Competency (UoC) and UoC packaging according to prescribed format, and track record of planning and delivering similar projects on time and within budget.
